



**ASSUMPTION OF RISK AND WAIVER OF LIABILITY  
RELATING TO CORONAVIRUS/COVID-19/INFECTIOUS DISEASE**

As we address unprecedented circumstances, we all have a responsibility to minimize the risks associated with the COVID-19 pandemic. Windy City Ninjas has implemented preventive measures to reduce the spread of Covid-19; however, we cannot guarantee that you or your children will not contract any infectious communicable disease, such as, without limitation, measles, mumps, influenza, COVID-19, chicken pox, rubella, and whooping cough, regardless of whether the source is a customer, participant, instructor, staff member, or any other individual present at the facility.

By signing the agreement, and by participating or allowing my child(ren) to participate in any activity at Windy City Ninjas, I acknowledge the contagious nature of COVID-19 or any other infectious communicable disease and I voluntarily assume the risk that I or my child(ren) may be exposed to an infection, disease, virus, bacteria, fungi and/or exposed to or infected by COVID-19 and may result in personal injury, illness, permanent disability and death.

I understand that the risk of becoming exposed to a virus, bacteria, fungi, infection, disease or infected by COVID-19 or any of the ailments listed above at the facility may result from actions or omissions, negligence, including, but not limited to, the facilities instructors, volunteers, coaches, students, spectators and their families. I acknowledge that I must comply with all set procedures to reduce the spread of any virus while I or my child(ren) are participating at the facility.

I attest that:

- I and my child are not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I and my child has not traveled internationally within the last 14 days.
- I do not believe I or my child have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I and my child have not been diagnosed with an active case of Coronavirus/Covid-19.
- I and my child are following all CDC recommended guidelines to limit exposure to COVID-19.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expenses, of any kind, that I or my child(ren) may experience or incur in connection with me or my child(ren's) attendance. By signing this document, I hereby release, covenant not to sue, discharge, and hold harmless to the facility, its owners, employees, agents, representatives of and from the Claims including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the facility, its employees, instructors, coaches, agents and representatives, whether a virus, bacteria, fungi, infection, disease, or COVID-19 infection occurs before, during, or after participation in the facility.
